Re: **PARITY BILL INTRODUCED** (Parity Alert #21 Rev.)

The “Paul Wellstone Mental Health Equitable Treatment Act” ([S. 486/H.R. 953](#)) was introduced on February 27 by Senators Pete Domenici (R-NM) and Edward Kennedy (D-MA) and Representatives Patrick Kennedy (D-RI) and Jim Ramstad. More than 200 members have already expressed their support by signing on as cosponsors.

Action:

- 1) Constituents should thank the cosponsors of “Paul Wellstone Mental Health Equitable Treatment Act” for their support, and urge them to continue to work for its speedy passage.
- 2) Continue your outreach to non-cosponsors and urge them to cosponsor this important legislation.
