Re: Majority Cosponsors Parity (Parity Alert #23)

The "Senator Paul Wellstone Mental Health Equitable Treatment Act" (S. 486/H.R. 953) has now gained a majority of cosponsors in both the House and the Senate! <u>Congratulations</u> and thank you to all national organizations and your state affiliates which have been pressing members of Congress to make this very visible commitment that will ease insurance discrimination against mental disorders. We also achieved a significant victory when Senator Pete Domenici secured \$5.4 billion in the final <u>Budget Resolution</u> to offset costs associated with enactment of parity legislation. See "Background" below for details.

Introduced on February 27 by Senators Pete Domenici and Edward Kennedy and Representatives Jim Ramstad and Patrick Kennedy, this critical legislation now has 57 cosponsors in the Senate and 231 in the House. Only a handful of the previous cosponsors have not signed on to the new bill. However, many of the newest Members of Congress are yet to express their support for mental health parity. Please ask constituents to continue their outreach efforts to these legislators – see "Targets" list below – and to be sure to thank Members who have cosponsored.

Background: We're thrilled to report that Senator Domenici has secured \$5.4 billion over 10 years in the Budget Resolution approved April 11 to offset any costs associated with enactment of mental health parity legislation. One will not find a line item or a description of that \$5.4 Billion anywhere in legislative language but the funds were included in Function 550. See this April 11 colloquy between Senators Domenici and Nickles, from the Congressional Record page \$5307.

MENTAL HEALTH PARITY ASSUMPTION

Mr. DOMENICI. Mr. President, I compliment my friend from Oklahoma and the Chairman of the Senate Budget Committee on a job well done. He has skillfully navigated a difficult course to produce the budget conference report before us today. Congratulations.

I would like to raise the issue of mental health parity as the Senate debates the FY 2004 Budget Resolution Conference Report.

It is my understanding the conference report before us assumes the revenue impact of enacting a mental health parity law by using the Congressional Budget Office score for S. 543 from the 107th Congress of \$5.4 billion over 10 years. However, I want to make sure that this is indeed the case because the assumption I just mentioned is not specifically referenced in the conference report. Rather, the overall revenue number is such that it assumes Congress will pass mental health parity legislation.

Mr. NICKLES. I understand the concern of the distinguished senior Senator from New Mexico about mental health parity, and I would concur with my colleague's assessment. The conference report does assume the revenue impact of enacting mental health parity legislation.

Mr. DOMENICI. I thank the distinguished Chairman for his consideration and explanation of this important matter.
