CHS-I: Understanding Homeland Security and Its Impact on National Security

Understanding Homeland Security and Its Impact on National Security is a course specifically designed to establish an entrylevel exposure, broad overview, and understanding of homeland security and its impact on national security. The participant will build both a vocabulary of terms and knowledge base used in the fields of homeland security and disaster preparedness. In doing so, this course will introduce and strengthen the participant's understanding of homeland security and its impact on national security as well as understanding the events precipitating the formation of the United States Department of Homeland Security (DHS) and its roles and responsibilities as they apply to national security. The formation of DHS, its organizational structure, its mission, and the various homeland security presidential directives that guide it will also be discussed. CHS-II: Introduction to the National Infrastructure Protection Plan (NIPP)

This course is designed to build on an already-established, basic, entry-level exposure to the field of homeland security. It presents an understanding of homeland security in relation to the National Infrastructure Protection Plan (NIPP) as it pertains to the Nation's Critical Infrastructure and Key Resources (CI/KR) and their impact on national security. In doing so, this course will enable the student to come away with an understanding of what exactly homeland security is designed to protect with respect to physical resources, not only at the national level but also at the state and local levels. The student will be exposed to the resources available to them within The Department of Homeland Security and understand the means to utilize these in his/her day-to-day life, in the performance of their duties on the job as homeland security professionals both within and outside the government. It is critical to understand what CI/KRs the departments and agencies of the federal government—through the auspices of the DHS—is mandated by law and Executive Order to protect.

Since the catastrophic attack of 9/11, the full force and might of all departments and agencies within the United States government have made a most concerted effort to deter another such event. In addition to this, The United States of America has also—by policy, procedure, law, homeland security presidential directive, and executive order—established certain guidelines and parameters under which it operates to mitigate the effects of not only another terrorist attack but also an emergency of any nature (*i.e.* manmade—HAZMAT—disaster or natural disaster).

CHS-III: Introduction to Weapons of Mass Destruction

This course presents an understanding of homeland security in relation to the potential use of Weapons of Mass Destruction (WMD) by terrorists against the United States of America and its citizens. In doing so, this course will enable the student to come away with an understanding of what exactly WMDs are and how they affect infrastructure andindividuals expossed to them. The student will be shown the effects of employing WMDs on a society and become familiar with the advantages and disadvantages of doing so. Because of the devastation and panic that WMDs can cause, it is essential that individuals be aware of and most familiar with them as weapons and resources in the terrorist's arsenal that no doubt will be used at some future date during the conflict in which we are currently engaged.

It is critical to understand that the use of WMDs is one of the most terrifying aspects of the War on Terror. Participants will be made aware that WMDs do, however, have limitations and that their effectiveness is based on target selection and the environment. Since the catastrophic attack of 9/11, all departments and agencies within the United States government have made a most concerted effort with their full force and might to deter another such event. Specifically, they have focused on deterring a chemical, biological, radiological, nuclear, and explosive (CBRNE) attack. When we speak of the use of WMD by terrorists, it must be realized that they have quite simply transformed a major part of nature into weapons of death and destruction.

CHS-IV: Advance Weapons of Mass Destruction & Terrorism

CHS-IV is designed to build on the knowledge of those who have successfully completed CHS-I, CHS-II, and CHS-III. Specifically, CHS-IV aims to greatly expand the participant's knowledge of both Weapons of Mass Destruction (WMDs) and the terrorists who use them in their assaults against the free nations of the world. CHS-IV presents in-depth information giving participants advanced exposure to terrorists and terrorist organizations that use WMDs. Participants review case studies of significant overseas terrorist incidents involving the use of WMDs. Through the case studies, they observe how WMDs influence the politics of nation-states.

Areas of emphasis include terrorist groups and WMD identification, response to WMD use, and actions to mitigate WMD effects. In particular, the "mechanisms-of-injury" related to specific WMDs are addressed. Also addressed specifically are standard medical protocols for treating the effects of various chemical, biological, radiological, and nuclear explosive WMDs and estimates for successful recovery to such exposures (informed by medical and actuary statistical data). All Americans will likely be involved in, or required to respond to, a WMD attack at some point in their lifetime. Regarding such attacks, it has been stated repeatedly, "It's not if but when, and it's only a matter of time." In this light, individuals holding advanced certification in homeland security must be well-versed in the mindset of the terrorist and also be familiar with rationale the terrorist uses in weapon selection.

The Impact of War on Children

UNICEF claims that for every 20 children, one will have their life taken by a landmine. This comes as little surprise, considering that during the last 20 years, children have been a part of 16 wars in at least 25 countries. This has resulted in approximately two-million children's lives having been lost in the last decade; countless more have suffered the traumas of unending raging wars. Children, toddlers, and infants have seen untold numbers of family members and peers killed. Some children are left orphaned, others are absorbed into the social system, perhaps a few have remaining family to live with, and of course an unknown number are recruited as child soldiers. All are forever touched by the ravages of war. While adults fight for their proud beliefs and ways, their children are left in an emotional, mental, physical, financial, social, sexual and spiritual cauldron.

It is imperative that anyone in service professions, regardless of post, realize the devastation wrought on children of war. This course prepares the learner to understand the multifaceted traumas in which these children are plagued. A journey will be taken through each of the seven core areas of development (emotional, mental, physical, financial, social, sexual and spiritual) to understand the impact war trauma has on the life of children. Whether on the streets of New York or Baghdad, the negative components of Combat and Operational Stress (COS) have threaded through the history of warfare. 

Deploying an Organizational Pandemic

Pandemics are a recurring natural event, and while they cannot be predicted with any accuracy, they can be planned for. In April 2009, an outbreak of a new strain of influenza virus was identified as influenza A (H1N1) virus, commonly referred to as "swine flu." Within days, hundreds of suspected cases, many fatal, were discovered in Mexico, and then cases were being identified in the U.S. and several other countries in the Northern Hemisphere.

Soon thereafter, the U.N.'s World Health Organization (WHO), along with the U.S. Centers for Disease Control and Prevention (CDC), voiced their concern that the A(H1N1) had the potential to become a worldwide flu pandemic. In response the WHO raised its pandemic alert level to "Phase 5" out of the six maximum, signaling that a pandemic is imminent. This

is the most recent event that has caused great concern among medical professionals and underscores the importance of preplanning for these events.

Bought Out and Spent: Recovery from Compulsive Shopping and Spending

We all shop for many reasons; the addict buys to relieve anxiety, and over time the buying creates a dysfunctional lifestyle. More and more of the addict's focus is placed on shopping and concealing any compulsive spending. A 2006 Stanford University study estimated that 6% of the U.S. population suffers from compulsive buying disorder. Men and women suffer equally from this disorder, and the average American has over \$10,000 in discretionary credit card debt. Fights about money and spending are the number one reason for conflict and divorce among couples.

What causes compulsive shopping/spending? Underlying issues include:

- Emotional and/or material deprivation in childhood
- An inability to tolerate negative feelings
- · A need to fill an inner void
- A need to seek excitement and approval
- A need to attain perfection
- A need to gain control

This overindulgence contributes to the next generation of compulsive shoppers and spenders.

Successful treatment of this disorder helps an addict find a peaceful financial and emotional balance, allowing them to enjoy better relationships with themselves and others. 



Interviewing, Interrogations, and Detecting Deception

When in an interview with a suspect or a witness, there are many factors to take into consideration, including the difference between approaching a suspect and a witness or specific mannerisms to watch for. When questioning a witness, one must take into account that a witness memory is vulnerable and can be affected by emotional involvement, prejudices, or simply how the witness feels at the time of questioning.

When a suspect is interrogated, several issues may arise; additionally, if the suspect is guilty of the crime committed, he or she may resort to lying. It is the interrogators job to decipher between the truth and what the suspect may state as a lie.




